HOW TO:

Build a GS1 GTIN Into a GS1-128 for Produce

If you need to encode trade item data for logistic units that are not intended to pass through retail point of sale (like cartons, cases, pallets, and returnable assets), you need a GS1-128 barcode. The GS1-128 symbology supports fast and accurate tracking of inventory, adding visibility to your supply chain. Additional information—like Batch/Lot Numbers and Best Before dates—can be encoded in GS1-128 barcodes, adding additional capability to validate data for improved traceability.

The combination of unique identification and standardized data content makes GS1-128 barcodes invaluable for sharing rich data content between trading partners and across food sectors in the supply chain.

Now, how do you create GS1-128 barcodes to share product information with your trading partners? All you need is a GS1 Company Prefix to get started.

Understanding Your Global Trade Item Number (GTIN)

GTIN-14 in a GS1-128 barcode is always 14 numeric digits.



- Indicator Digit**
May have a value of 1 through 8 to identify different levels of product hierarchy.
- GS1 Company Prefix**
NOTE: Add a zero in front of the U.P.C. Company Prefix to convert your U.P.C. Company Prefix to a GS1 Company Prefix.
- Item Reference Number**
Assigned by the owner of the GS1 Company Prefix.
- Calculated Check Digit Reference**
Calculation based on previous 13 digits to ensure global uniqueness.

What's an Application Identifier (AI)?

An Application Identifier is instruction to the barcode scanner to let it know how to read the next piece of information. The AI (01) indicates that the GS1 AI data field contains a GTIN. This AI is fixed in length and encodes 14 numeric digits. The AI (10) indicates that the GS1 AI data field contains a Batch/Lot Number. This AI is variable in length and encodes a maximum of 20 alphanumeric characters.

Creating Your GS1-128 Barcode

To create your GTIN-14 and encode it into a GS1-128 barcode, follow these simple steps:

STEP 1: ASSIGN AN INDICATOR DIGIT

An **Indicator Digit** is used to identify the level of the packaging hierarchy of a product. The values for use are 1-8.

STEP 2: IDENTIFY YOUR GS1 COMPANY PREFIX

STEP 3: ASSIGN YOUR ITEM REFERENCE NUMBER

Assign your **Item Reference Number** based on the length of your GS1 Company Prefix. Remember, as a brand owner, you create your own Item Reference Number.

Note: The total number of digits from Steps 1, 2, and 3 must equal thirteen.

STEP 4: CALCULATE THE CHECK DIGIT

Calculate the **Check Digit**, which will go at the end of your new number. We recommend using the GS1 US Check Digit Calculator, available on our website at:

www.gs1us.org/checkdigitcalculator.

STEP 5: FINALIZE

Insert your 14-digit formatted GTIN and Batch/Lot Number into the GS1-128 barcode, along with Application Identifiers (AIs): one AI will precede the GTIN; another AI will precede the Batch/Lot Number.

Note: The Batch/Lot Number AI helps improve the traceability of the GTIN-marked item. The number may be a production lot number, a shift number, a machine number, a time, or an internal production code—whatever your company uses to identify a particular batch or lot. The data in your AI is an alphanumeric string of up to 20 characters.

STEP 6: PRINT
